

Alter High School Tuition Commitment Form 2010-11

There are three tuition payment options:

Option 1 - Full Payment

Payment may be made in full prior to June 18, 2010 directly to Alter High School.

Option 2 - Partial Payment with 10 Monthly Payments

Partial payment (in an amount of your choosing) may be made prior to June 18, 2010 and monthly payments for the balance will begin July 5 or July 20, 2010. A 6% fee will be assessed on the balance remaining after the partial payment. All monthly tuition payments are handled by FACTS Management.

Option 3 - 10 Monthly Payments

Monthly payments begin July 5 or July 20, 2010. A 6% fee will be assessed on the total amount owed. All monthly tuition payments are handled by FACTS Management.

FACTS PEACE OF MIND (POM) BENEFIT

The POM benefit will pay any FACTS unpaid balance (except payments in arrears) in the event of the death of the responsible party who has signed this agreement or his/her legal spouse. Coverage is only available to individuals under age 70. Coverage does not apply when cancer, or complications related to cancer, cause death and the individual has received or been advised to receive medical advice, diagnosis, or treatment for cancer at the time coverage begins. The nonrefundable annual fee for this benefit is \$12.00 per FACTS agreement, and the fee will be added to your FACTS Enrollment Fee if you elect to enroll. You will be automatically reenrolled in the POM plan each consecutive year you have a FACTS Automatic Tuition Payment Agreement.
